Project Overview

The City of Edgerton seeks funding from the U.S. Department of Transportation (USDOT) for funding available through the Safe Streets and Roads for All (SS4A) for development of their first Comprehensive Safety Action Plan.

SS4A is a discretionary BIL program that has a local match requirement of 20%. The City of Edgerton is requesting \$45,000 from the Build Kansas Fund. This request has the potential to unlock \$180,000 in federal funds.

The next deadline for SS4A applications is May 16, 2024. The Build Kansas Fund application was received on March 15, 2024.

We are currently under construction for a new community center, park renovation, and sewer extension that are anticipated to fully leverage their respective budgets and beyond. Additionally, the ARPA money received has been used for our Lead Service Line Inventory as required through the EPA Lead and Copper Rule Revision. If successful, we anticipate this project will prepare The City of Edgerton for future federal grant applications for capital projects related to improving safety of our roadways. These subsequent grant applications, if successful, will leverage additional federal funds for the improvement of Kansas roads.

The City of Edgerton Kansas is requesting the support of the Kansas Department of Transportation through providing matching funds for our proposed Edgerton Safety Action Plan. We are requesting the Kansas Build Fund consider funding our 20% match required to pursue federal funding through the FY24 Safe Street and Roads for All (SS4A) a Bi-Partisan Infrastructure Law (BIL) program.

Project Description:

The Edgerton Safety Action Plan will be a new comprehensive action plan to reduce serious injury and fatal crashes throughout our road system. The City of Edgerton is connected to multiple economic centers including the BNSF Intermodal Facility, Logistics Park Kansas City (LPKC), the Kansas City metropolitan area, and sources of the global food supply through our local farms. As Edgerton continues to grow both with new residential and commercial developments as well as the continued expansion of LPKC it is essential that we evaluate the safety of the current and future expansion of our road system.

The Edgerton Safety Action Plan will include data gathering measures to identify safety related problems and provide strategies to address and remedy those problems. This plan will incorporate community input and collaborate with connected stakeholders like Johnson County, KDOT, and other connected transportation entities to create an inclusive approach to safety. The Edgerton Safety Action Plan will establish achievable goals for the City to greatly reduce crash severity as well as improve the safety culture in our community.

The results of this plan will include safety related policies and procedures for future transportation development and equity of our road system for all users. Inclusion for the safety of vulnerable users of our road system like bikers and pedestrians will also be incorporated into the safety goals for the Edgerton Safety Action Plan.

Budget Narrative:

The City of Edgerton has evaluated the costs for comprehensive safety action plans for other municipalities in our area including the City of Paola (\$144,500), the City of Spring Hill (\$237,500), Unincorporated Johnson County (\$270,000) and the Prairie Band Potawatomi Nation (\$267,900). Considering the population of Edgerton as well as the additional transportation safety considerations related to frequent rail traffic and freight traffic from LPKC, the cost estimate for the Edgerton Safety Action Plan is anticipated to be approximately \$225,000.

The City of Edgerton is requesting \$45,000 (20%) of the project costs to be covered through the Kansas Build Fund in support of our application for \$180,000 (80%) through the FY24 SS4A Program federally funded by BIL.
