

BIL Overview

- **Bipartisan Infrastructure Law (BIL)**
 - AKA Infrastructure Investment and Jobs Act (IIJA)
- **National Infrastructure Investment = \$1.2 Trillion across 5-year lifespan**
 - Nearly 400 programs across 12 Federal Agencies
 - 40% awarded via Discretionary grants / 60% awarded via Formula grants




■ Discretionary ■ Formula

Important Notes



- The Hub is **not** selecting projects
- Projects only receive BKF funding **if awarded** a federal grant
 - Federal agencies make project selections and provide award notification
- This is additive only
 - Communities can apply without requesting Technical Assistance **OR** making a Build Kansas Fund Application



Federally Required Match: 5% of total project cost


Summary: This project is for land acquisition for future development and investment by the tenant for aeronautical development and infrastructure access.



Project Name: Great Plains Industrial Park/City of Parsons Emergency Water Connection



Federally Required Match: 25% of total project cost

Summary: This project is to install 8 miles of water pipeline, rehabilitate a water tower, and enhance fire suppression to improve system integration, increase storage capacity, and strengthen regional water resilience.

Local Contribution (Cash):	\$74,382	1.25%
Federal Funding Unlocked	\$4,462,938	75%
Total Project Costs:	\$5,950,584	100%



BIL Program: FEMA | Building Resilient Infrastructure and Communities (BRIC)

Project Name: Electronic Reclosers Project

Federally Required Match: 25% of total project cost

Summary: This project is to install oil free automatic reclosers on existing utility poles to enhance wildfire hazard mitigation efforts and reduce the risk of electrical system-related fire ignitions.

BKF Request Amount:	\$427,500	23.75%
Local Contribution (Cash):	\$22,500	1.25%
Federal Funding Unlocked	\$1,350,000	75%
Total Project Costs:	\$1,800,000	100%



Project Name: Garnett Municipal Airport – Runway 1-19 Reconstruction – Phase 2 Land Acquisition

Federally Required Match: 10% of total project cost

Summary: This project is for the expansion and improvements to runway 1-19 at Garnett Municipal Airport – Phased land acquisition.


BKF Request Amount:	\$15,331	5%
Local Contribution (Cash):	\$15,332	5%
Federal Funding Unlocked	\$275,960	90%
Total Project Costs:	\$306,623	100%



2025-096-SWKRPC – City of Garnett

- Acquire property and easements to north to extend runway 740' min.
- Needed for future runway extension and location of navigation equipment and lighting equipment.

BIL Program: FEMA | Building Resilient Infrastructure and Communities (BRIC)

Project Name: Load Centers and Transmission Line Project

Federally Required Match: 25% of total project cost

Summary: This project is to install steels and concrete poles to strengthen transmission lines against high wind events and replace aging infrastructure with modern load centers for improved reliability.

BKF Request Amount:	\$950,000	23.75%
Local Contribution (Cash):	\$50,000	1.25%
Federal Funding Unlocked	\$3,000,000	75%
Total Project Costs:	\$4,000,000	100%



BIL Program: DOT | Airport Infrastructure Grant (AIG)

Project Name: Newton City-County Airport (EWK) Runway 8-26 Reconstruction

Federally Required Match: 5% of total project cost

Summary: This project is to make improvements to the EWK Runway 8-26 consisting of repairing the longitudinal, edge, and transverse thermal cracking and patch failures.

BKF Request Amount:	\$73,150	4.75%
Local Contribution (Cash):	\$3,850	0.25%
Federal Funding Unlocked	\$1,463,000	95%
Total Project Costs:	\$1,540,000	100%

Previous BKF Application Adjustment Request

- Stevens County/Hugoton Municipal Airport (2025-092-GP)
- Airport Investment Grant (AIG)
- Request to Reduce Local Contribution
 - Calculated incorrectly
 - Used 5% of total project cost vs. 5% of project match amount
 - The revised Local Contribution of \$1,825 from the City is 5% of the project match amount, as requested of BKF applicants.






