
#### Safe Streets and Roads for All (SS4A) Grant Program

- Funding Agency: U.S. DOT Funded by IIJA
- FY25 Due June 26, 2025
- Planning and Demonstration Grants safety action plans, supplemental safety planning, and/or safety demonstration activities.
- Implementation Grants for projects that are in existing roadway safety action plan.
- 20% cost-match requirement
- Implementation: \$982M
  - Planning & Demonstration Grants: \$402M
    - \$100k to \$5M (400 to 700 expected awards)
  - Implementation Grants: \$580M
    - \$2.5M to \$25M (40 to 70 expected awards)
- Eligible Applicants:
  - Cities, counties, MPOs, Tribal govt.



If an eligible applicant cannot meet this cost share expectation or has other reasons why they should be excluded from this expectation, they may justify that in their Build Kansas Fund application. Eligible applicants that team together on an application or demonstrate regionality may also be considered for exclusion on a case-by-case basis."




